

What inspired you to set up St Luke Fund?

The great Chinese philosopher spoke about benevolent love (仁) and Mother Teresa of Calcutta of India gave up her comfortable life in a Covent school around 1950 to serve the poor, sick, orphaned and dying.

She gave all her possessions to serve 'The poorest of the poor' on the street of Calcutta and later opened many orphanages, hospices, day-care centres, and schools.

Many of us perhaps also have a burning desire to change the world, many of us would also like to leave something behind, even in a small way.

How would you recommend the Legacy Fund to others?

'Where would my money go to?', 'Do they spend some, if not most of the money, in administration and media promotion?', 'How long will my donation last?' and 'Do I have a say on how the money will be spent?' are some of the questions in our minds.

The Legacy Fund of ACCF was set up with the purpose to take away the above concerns and to enshrine the future of the funds for our donors.

Like the Capital Fund of ACCF, only interests derived from safe investments such as term deposits will be distributed each year. There will be no administration fees or media advertisements fees, a donor can nominate the purpose of the fund distribution, and will know how much the fund is distributed from ACCF in its annual report.

How much would I need to donate? Usually, it will be \$250,000 for the fund to be named after you or someone you wish to remember.

Report on ACCF Flood Appeals



Climate change has caused heavy rainfall which caused record-breaking floods in Queensland and New South Wales in early 2022. It has caused immense hardship for our community; a lot of businesses and family homes were submerged in water. Lismore is a city in north-eastern New South Wales. Following days of flooding in Brisbane, the Wilsons River at Lismore reached 14.4 metres. Nearly all the CBD was completely underwater.

Report on ACCF Flood Appeal – Lismore & ACCF Flood Relief – Here4You

Unexpectedly, climate change caused by La Nina continued with heavy rainfall and flooding in October 2022. By the end of the month, swollen rivers flooded landscapes from Southern Queensland and New South Wales to Northern Victoria. Once again, ACCF launched **ACCF Flood Relief – Here4You** on 1 December 2022.

This time the appeal focused on direct assistance to families and communities affected by flood. The Foundation had chosen Australian Lions Foundation (ALF) as the sole beneficiary of this fundraising campaign. Like ACCF, ALF is a funding body and provides emergency grants to local Lions Clubs in the flood-stricken communities. Grants are used to provide the community with basic needs to return to home and start over. This includes items such as, white goods, bedding, linen, pillow, lounge furniture, kitchen, wardrobes, dining tables and chairs etc.









The fundraising campaign was formally closed on 4 February 2023 after the Chinese New Year Celebration Dinner. Total donations received was \$92,924 and the full amount was forwarded to ALF. 

What kind of ongoing help does your organization need?

The Australian Lions Foundation is always appreciative of any assistance that is given as it continues to support those in need. These days the needs of not only individuals and families are increasing and we aim to support them in any way. Our Compassionate support identifies the needs of families through our Lions Clubs and these become a prime area of assistance.

Recent support for the Foundation through the assistance of Channel 9 A Current Affair is to help the Tadros family. You may recall the helicopter crash on the Gold Coast late last year. Simon Tadros lost his wife in the crash and he and his son were severely injured needing a long period of medical care and support. The Foundation will be there to help by raising funds and helping administer as we try to give them some normal lifestyle in what are difficult situations. This is just an example of the diversity of involvement the Foundation has.



Funds & Grants Assessment Committee 2021 Updates and 2022 Report

The impact of Covid-19 in recent years had significantly disrupted our lives in general, but in particular magnified the risk of isolation, causing significant impact on the wellbeing; social and emotional challenges for some vulnerable communities. In response to these challenges, the 2022 Funds and Grants program continued to prioritise our focus on Covid-specific needs for some targeted disadvantaged groups. We adopted a themebased approach and a 2-stage application process i.e., grant consideration begins with an initial expression of interest, followed by an invitation to submit a full proposal if shortlisted.

Grants were offered across two categories: support for the Aged; and support for Disabilities and Special Needs. Both categories aimed at supporting projects that contribute to fostering community engagement, social connection and participation activities; addressing social isolation and risk of mental health challenges faced by these disadvantaged cohorts. A sum of \$99,290 was respectively awarded to 12 partner organisations.

Funds were awarded to 7 organisations in the Disabilities/Special Needs category – supporting children/youth and their families.

2021 "Start Over" Project Updates

The 2021 "Start Over" projects delivered by our partner organisations to support victims of domestic violence who had left unsafe relationships to make a new start were completed in November 2022. These projects were invaluable in helping women and families feel safe and secure whilst working through the trauma of domestic crisis.

Projects Highlights:

Detour House

This project was partly supported by the Pak Family Fund. 33 women and girls received support through the fund and starter packs are prepared for distribution to an additional 20-30 women and girls.

Funds have been used to establish new homes for women, support them to stay connected through technology, paid for removalist expenses, and provided clothing and groceries for residents relocating.

Fairfield Women's Health

14 women and their children who had escaped from abusive/life threatening relationships received financial assistance ranging from food vouchers, rent arrears, electricity bills, necessities for children, phone credits and other necessities etc.

Client P: is on bridging visa and has 2 dependents when separated from an abusive relationship.

ACCF fund has helped her with rent arrears and electricity bill. It was a big relief for Client P at the time of financial difficulty.

Client C: has started building a new life after leaving an abusive relationship. Client C cannot work as she is pregnant. Food vouchers were given as she needed some money for phone credits and other necessities.

Client B has a very complex situation. The DFV has left her with mental health issues. She also has to care for a child with mental and behavioural issues. **ACCF fund has saved her from eviction which also meant to help relieve mental and physical distress.**

The Northern Centre



A self-funded 12-month pilot program supporting women with or without children who have left violence to navigate to services and their challenges that trigger them to return to violence.

The SafeT (transition) program was introduced to provide ongoing support to women and families leaving violence to navigate to services and challenges to avoid the triggers that usually see them return to violence.


87 clients received a wide range of supports based on brokerage funds including legal advice, making police reports, access to financial counselling and emergency relief, parenting program, grocery vouchers, housing support and many other supports.

Wash House

60% of the funds was used to assist 18 victims of domestic violence secure their homes with security cameras, replacing door locks and security doors and safety equipment. The remaining 40% was used to assist in purchasing food, toiletries, clothing, transport, safe phones and in some cases health care for injuries sustained in a domestic incident.





Principal activities

The principal activities of the Foundation during the financial year were to raise funds to support beneficial community projects, respond to the urgent need of those in a state of emergency and to promote multiculturalism in our society.

Review of operations

The surplus for the year amounted to \$213,839 (2021: surplus of \$202,486).

Significant changes in the state of affairs

Significant changes in the state of affairs during the financial year were as follows:

As a result of the COVID-19 pandemic and in light of social distance requirements, the decision was made to cancel the 2022 Chinese New Year Dinner. 2022 Annual Dinner was held at the Zilver Restaurant, Haymarket on 22 October 2022.

ACCF was very grateful to receive a generous donation of \$250,000 in June 2022. The donation was the fourth Legacy Fund named ANSA Family Fund. Income derived from the fund is to be used for aged related projects.

Indemnification of officers and auditors

The Foundation has not, during or since the end of the financial year, except to the extent permitted by law, indemnified or agreed to indemnify an officer or auditor of the Foundation or of any related body corporate against a liability incurred as such an officer or auditor.

Events since the end of the financial year

No matter or circumstance has arisen since 31 December 2022 that has significantly affected the Foundation's operations, results or state of affairs, or may do so in the future.

1 Summary of significant accounting policies

The principal accounting policies adopted in the preparation of the financial report are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

(a) Basis of preparation

These general purpose financial statements have been prepared in accordance with Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board, the *Charitable Fundraising Act* 1991, and the *Charitable Fundraising Regulation* 2021.

Australian Chinese Charity Foundation Inc. is a not-for-profit entity for the purpose of preparing the financial report.

(i) Compliance with Australian Accounting Standards – Simplified Disclosure Requirements

The financial statements of Australian Chinese Charity Foundation Inc. comply with Australian Accounting Standards – Simplified Disclosures as issued by the Australian Accounting Standards Board (AASB).

(ii) Historical cost convention

These financial statements have been prepared under the historical cost convention, except for certain assets which, as noted, are at fair value.

(iii) Functional and presentation currency

Items included in the financial statements are measured using the currency of the primary economic environment in which the Foundation operates ('the functional currency'). The financial statements are presented in Australian dollars, which is the Foundation's functional and presentation currency.

(b) Revenue recognition

(i) Revenue

AASB 15 Revenue from contracts with customers outlines a five-step model for the recognition of revenue. A contract is within the scope of AASB 15 if

- the entity has an enforceable contract with a customer, and
- the contract includes sufficiently specific promises for the Not-for-Profit entity to transfer goods or services to the customer or third-party beneficiaries.

Under AASB 15 income is only recognised as the obligations under the contract are satisfied, potentially resulting in a deferral of income.

Ticket sales revenue

The Foundation sells tickets to members and the public for their annual dinner and Chinese New Year dinner. Upon the sale of the tickets, the Foundation has an obligation to provide dinner on the specified dinner date. Revenue is recognised at a point in time once the dinner occurs.

Raffle and auction revenue

At the dinner events, the Foundation holds a raffle with multiple prizes up for the win. In order to be able to participate in the raffle, invitees present at the dinner have the ability to purchase raffle tickets which will allow them to participate in the raffle draw. The Foundation's performance obligation is fulfilled at the time of the draw as each raffle ticket holder is able to participate in the raffle and claim the prize if they have the winning number. The revenue from the sales of raffle tickets is recognised at a point in time.

(ii) Income

Donations income

Donations represent monies received into the Foundation's bank accounts. Common with most organisations dependent on such contributions, the Foundation is unable to establish control over voluntary donations prior to their initial entry into the accounting records. As such, unless specific performance obligations exist, donation income is recognised when received or when the Foundation obtains the right to receive the contribution, it is probable that the economic benefits comprising the contribution will flow to the entity and the amount of the contribution can be measured reliably. When specific performance obligations exist, donation income is recognised as the obligations under the contract are satisfied

Membership income

The Foundation has four levels of memberships from which it receives income. The monies received for the membership are treated as donations and are recognised accordingly upon receipt.

Sponsorship income

The Foundation receives income from sponsors in order to enable the Foundation to further its objective. The income is recognised in the profit and loss upon receipt of the funds.

Legacy Fund revenue

The legacy fund was officially launched in June 2018. The legacy fund allows members and other contributors to donate to the Foundation. Under the deed signed for the legacy fund, donors have the ability to propose the cause to which donations should be made. Although the promise to provide donations to a cause proposed by the donor is a promise to transfer goods or services, it is not a sufficiently specific performance obligation. While the promise to provide donations is distinct and the Foundation can identify at the end of the year whether or not it has donated to the cause proposed, it cannot identify when its obligation is fully satisfied and cannot allocate the transaction price as the promise is continuous as long as ACCF exists. ACCF must be able to identify when the performance obligation is satisfied for the promise to be identified as sufficiently specific. Accordingly, the Foundation recognises the donations as income when it gains control of the donated cash.

(iii) Finance income

Interest income is calculated by applying the effective interest rate to the gross carrying amount of a financial asset except for financial assets that subsequently become credit impaired.

Interest income is presented as finance income where it is earned from financial assets that are held for cash management purposes.

(iv) Donations in kind

Donations in kind are not brought to account as revenue.

(c) Income tax

The Foundation is exempt from Income tax in accordance with Div 50 of the *Income Tax Assessment Act* 1997. Under this division, the Foundation is classified as a non-profit organisation.

(d) Cash and cash equivalents

For the purpose of presentation in the statement of cash flows, cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities in the balance sheet.

(e) Receivables

Trade receivables are recognised initially at the amount of consideration that is unconditional, unless they contain significant financing components when they are recognised at fair value. They are subsequently measured at amortised cost using the effective interest method, less loss allowance.

For trade receivables, the Foundation applies the simplified approach permitted by AASB 9, which requires expected lifetime losses to be recognised from initial recognition of the receivables.

(f) Payables

These amounts represent liabilities for goods and services provided to the Foundation prior to the end of the financial year which are unpaid. The amounts are unsecured and are usually paid within 30 days of recognition. Trade and other payables are presented as current liabilities unless payment is not due within 12 months after the reporting period. They are recognised initially at their fair value and subsequently measured at amortised cost using the effective interest method.

(g) Financial Assets

Initial recognition and measurement

Investments and other financial assets are initially measured at fair value. Transaction costs are included as part of the initial measurement, except for financial assets at fair value through profit or loss. Such assets are subsequently measured at either amortised cost or fair value depending on their classification. Classification is determined based on both the business model within which such assets are held and the contractual cash flow characteristics of the financial asset.

Classification and subsequent measurement

Financial assets at fair value through profit or loss are either: (i) held for trading, where they are acquired for the purpose of selling in the short-term with an intention of making a profit; or (ii) designated as such upon initial recognition, where they are managed on a fair value. Fair value movements are recognised in profit or loss.

Impairment of financial assets

The Foundation assesses at the end of each reporting period whether there is any objective evidence that a financial asset or group of financial assets is impaired. A financial asset or a group of financial assets is impaired and impairment losses are incurred only if there is objective evidence of impairment as a result of one or more events that occurred after the initial recognition of the asset (a 'loss event') and that loss event (or events) has an impact on the estimated future cash flows of the financial asset or group of financial assets that can be reliably estimated.

Where there has not been a significant increase in exposure to credit risk since initial recognition, a 12-month expected credit loss allowance is estimated. This represents a portion of the asset's lifetime expected credit losses that is attributable to a default event that is possible within the next 12 months. Where a financial asset has become credit impaired or where it is determined that credit risk has increased significantly, the loss allowance is based on the asset's lifetime expected credit losses. The amount of expected credit loss recognised is measured on the basis of the probability weighted present value of anticipated cash shortfalls over the life of the instrument discounted at the original effective interest rate.

(h) Rounding of amounts

The Foundation is of a kind referred to in ASIC Legislative Instrument 2016/191, relating to the 'rounding off' of amounts in the directors' report. Amounts in the directors' report have been rounded off in accordance with the instrument to the nearest dollar.

(i) Goods and Services Tax (GST)

Foundation's status as a Public Benevolent Institution (PBI) was confirmed in January 2014 by the Australian Taxation Office as part of its registration requirements for all non-profit entities, as was the Foundation's status as an Income Tax Exempt Charity from income tax in accordance with Div 50 of the Income Tax Assessment Act 1997. The Foundation enjoys certain other tax concessions and exemptions consistent with its status as a PBI, which relate to goods and services tax.

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the taxation authority. In this case it is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to the taxation authority is included with other receivables or payables in the balance sheet.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the taxation authority, are presented as operating cash flows.

(j) Critical estimates and judgements

The preparation of financial statements requires the use of accounting estimates which, by definition, will seldom equal the actual results. Management also needs to exercise judgement in applying the Foundation's accounting policies,

Estimates and judgements are continually evaluated. They are based on historical experience and other factors, including expectations of future events that may have a financial impact on the entity and that are believed to be reasonable under the circumstances. There are no significant estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amount of assets and liabilities within the next financial year.
